- Scrutiny and documentation.** Scrutiny will take place in Mill River Business Park. The club will not be using slot times for this event. Scrutiny will start at 16:00 hrs. to 20:30 hrs. Numbers must be collected before scrutiny in the scrutiny area. Scrutiny available Sunday morning from 07:30 to 09:00 hrs. subject to contacting the COC 087 9956312

The Rally office is in the Carraig Hotel, Main Street, Carrick-on-Suir, on Saturday evening. It will close at 21:30 hrs. for licences and collection of documentation. Please come early.
- SERVICE PARK.** One service vehicle per rally car. Spaces limited, first come first served. The service area is operating a one way system, Left Hand Entry, please obey Marshals.
- Overnight parking can be arranged for Saturday night. Security will be provided in Parc Ferme.
- Trailer park will be in the livestock mart yard from 16:00 hrs and gates will be locked at 21:00 hrs. on Saturday. It will reopen at 07:00 hrs Sunday.
- Trailers parked at owner risk.**
- All cars to go to Parc Ferme directly after scrutiny.
- All Competitors **must** be ready to start once they leave the S.A.C. Delays will not be accepted (if not ready when instructed to start the stage, the time it takes to get ready will be your penalty) **THE PENALTY IS SELF INFLICTED**, your co-operation is appreciated.
- We require a telephone number from either driver or navigator. This will be required at documentation. This is to help with the safe running of the event and to assist with car accountability. - 3 Deputy Coc is now Terence Kearney.

- 4 Reminder to Competitors App 2 14.1. Windscreen and windows shall bear no advertising, with the exception of a maximum 10cm high strip on the upper part of the windscreen, and, provided that this does not interfere with the visibility of the driver, an 8cm high strip on the rear window.
