This will be an open Loose Surface Autocross to be held under the international sporting code of the FIA, the GCR's of Motorsport Ireland including Appendices 86 & 87 of the current MI Yearbook, these supplementary regulations and other instructions that may be issued. The organisers have reserved the right to cancel or postpone the event or part of it in exceptional circumstances.

N.B. Any driver not signed on by 9.30 am may be excluded. Car bodywork must be in a presentable condition.

Entries: Open upon publication of these supplementary regulations and will close at 6pm on Wednesday 29th July 2015. Entries are limited to a maximum of 60. If more than 60 entries are received, a reserve list will operate.

All competitors wishing to take part must complete and return the official entry form and accompany it with the entry fee of €100 or €80 for class 8 competitors. Entry fee includes Personal Accident Premium.

A competitor who wishes to withdraw their entry must contact the event secretary on or before Thursday 30th July, otherwise their entry fee will not be returned.

The Competition: The event will consist of 3 timed runs. Each run will be 3 laps of the track. Overtaking is not permitted. Any competitor who feels he/she has been baulked/delayed by another competitor or has been yellow flagged by a Marshall can request a re-run but must do so immediately on return to the Paddock. A re-run will only be granted at the discretion of the Clerk of the Course. Deliberate delay in taking a scheduled run will result in forfeit of the run.

Timing/Results: Timing will be to the nearest 1/100th of a second from start to a flying finish. Results will be based on a competitor's fastest time (including penalties) for 1 run. The competitor with the overall fastest time (including penalties) for 1 run will be the winner. If a competitor is unable to complete a timed run, a maximum of 10 minutes will be applied.

Classes: 1. All Saloon cars up to 1450cc

- 2. All Saloon cars from 1451cc to 1650cc with not more than 2 valves per cylinder
- 3. All Saloon cars from 1451cc to 1650cc with more than 2 valves per cylinder
- 4. All Saloon cars from 1651cc to 2100cc
- 5. All Saloon cars 2101cc and over, 4WD & Turbo Charged Saloon Cars
- 6. Car Engine Specials
- 7. Motorcycle Engine Specials including buggies
- 8. Junior Class for 16-18 year olds holding a National B Licence in Saloon Cars up to 1650cc.

Must be under 18 on the day of 1st Championship Round.

All drivers must be in possession of a current 2015 competition licence and vehicle logbook. All competition vehicles must pass scrutiny. Safety equipment MUST include a safety harness and a securely fitted 1.75kg minimum AFFF (or FIA approved equivalent) fire extinguisher. Helmets and protective clothing must comply with standards set out in Appendices 2&3 for autocross events in the 2015 MI yearbook. **MUD FLAPS are obligatory on all wheels.** A maximum of three drivers per car will be permitted.

Each driver will be permitted one untimed familiarisation run during which stopping or holding back unnecessarily on the track is prohibited – this is not a competitive run. Timing will be as per Motorsport Ireland rules and the timekeepers times will be judged as final and correct. Penalties as per Appendix 86, Article 2 of MI 2015 Yearbook.

Competition cars must not leave the quarry compound under their own power during or after the event. The penalty for breach of this regulation is EXCLUSION.

AWARDS: Will be presented in the quarry after the final timed run.

- Fastest time of the day
- 1st, 2nd & 3rd in each class, provided there are 5 of more entries in each class (otherwise classes may be amalgamated) NOTE: Overall winner is not eligible for class prize
- Ladies Award
- Best Donegal Motor Club member
- Best Northern Ireland finisher
- Best Saloon Car on the day
- Best buggy on the day
