<u>Results:</u> The results of the competition will be based on each competitor's cumulative time for the total number of runs completed and any penalties incurred.

<u>Timing</u>: Timing will be to the nearest tenth of a second from standing start to Flying Finish. The maximum time to complete the stage is 10 mins. Times will be posted on the official notice board.

<u>Ties:</u> Will be resolved by reference to the fastest time on the last run and so on until the tie is resolved.

### Competitors:

Competitors must hold a 2016 competition licence. Double driving may be permitted and will be deemed to be separate entries. Separate entry forms must be completed and submitted. Passengers may be carried subject to their holding the appropriate competition licence, signing and indemnity form and paying the Competitors Personal Accident Insurance fee. M&S, forestry tyres and Tyre Warmers are NOT Permitted.

#### <u>Competitors competing in Midland East Championship – points will be counted as per</u> <u>Championship Reg.</u>

<u>Entries Criteria</u>: In the event of an excess of 70 entries being received the following criteria will be applied to all entries from the opening to the closing date of entries.

- 1. Midland East Rally Championship registered competitors received by closing date 1<sup>st</sup>, 2<sup>nd</sup> and 3<sup>rd</sup> in class.
- 2. 10 Entries to Westmeath & District Motor Club members who have assisted in running events by the Club and other clubs.
- 3. 20 Entries at organisers discretion.

### CLASSES:

- 1. All 2wd RallyCars up to 1450cc normally aspirated
  - A. Cars up to 1450 cc with only 2 valves per cylinder.
  - B. Cars up to 1450 cc with more than 2 valves per cylinder.
- 2. All 2wd Rally Cars from 1451cc to 1650cc normally aspirated
  - A. Cars from 1451 cc up to 1650 cc with only 2 valves per cylinder.
  - B. Cars from 1451 cc up to 1650 cc with more than 2 valves per cylinder.
- 3. All 2wd Rally Cars from 1651 cc up to 2100 cc normally aspirated.
  - A. Cars from 1651 cc up to 2100 cc with only 2 valves per cylinder.
    - B. Cars from 1651 cc up to 2100 cc with more than 2 valves per cylinder.
- 4. All 2wd Rally Cars from 2101 cc up to 3500 cc normally aspirated.
- 5. All 4wd Cars.
- 6. Rallycross Cars up to 1650 cc Buggies running in this class are not eligible for overall positions (class awards only).
- 7. Rallycross Cars from 1651 cc to 2150 cc.
- 8. Rallycross Cars over 2150 cc.
- 9. Rallycross Supercars

10. 14 – 16 years old up to 1000 cc Junior Speed Licence Holders, no co-driver

12. 16-18 years old up to 1600 cc co-driver allowed

Classes may be amalgamated if less than five entries are received in a particular class.

#### **PROTESTS**:

All protests must be as per the General Competition Rules, Chapter 11.

#### PENALITES

In addition to the penalties contained in the FIA International Sporting Code, the General Competition Rules, and The Motorsport Ireland Yearbook the following Regulations will also apply.

- 1. The Following will carry the penalty of exclusion from the Event.
  - a. Failing to report to the start when instructed to do so.
  - b. Not wearing safety clothing, helmet, or other equipment on the stage.
  - c. Overtaking between the flying finish and the stop point.
  - d. Driving in the opposite direction on the stage.
  - e. Servicing in a prohibited area.
  - f. Driving in a dangerous or reckless manner in the service/paddock area.
- 2. Maximum Time will be given for:
  - a. Failing to complete stage.
  - b. Missing a timed run.
- 3. Jump Start 30 seconds.

This policy document covers all those involved within the sport whether they are a Competitor, Entrant, Parent of a Competitor or Entrant, Team Official, Race Official or Motorsport Ireland Official whilst participating under Motorsport Ireland regulations regardless of their original national ASN. This policy is referred to in the entry forms for all events and is binding upon Competitors from other national ASNs in that manner.

2. Any content submitted online through the medium of the Internet by those participating or officiating at Motorsport Ireland sanctioned events should not contain material that could be deemed to be threatening, harassing, bullying, illegal, obscene, defamatory, slanderous or hostile towards any individual, team or entity participating or officiating at Motorsport Ireland sanctioned events or the Governing Body, Motorsport Ireland.

3. Content is defined as text, images, audio, video and any user generated content knowingly uploaded to the internet.

4. Furthermore it is the responsibility of those who participate or officiate at Motorsport Ireland sanctioned events to make sure that any third party associated with them does not submit content online which would be in breach of this policy. If a third party submits such content which is clearly associated with the participant or official, it is the participant or official who will be held responsible by Motorsport Ireland for the breach of this policy. In this regard the onus is on the participant or official to prove that the third party is not in any way associated with them.

5. All those who participate or officiate at Motorsport Ireland sanctioned events are reminded that the General Competition Rules, as defined within the current Motorsport Ireland Yearbook and / or Motorsport Ireland Website, apply at all times and that failure to adhere to the policies set out in this document will result in a breach of those regulations and the penalties and sanctions as set out in the current Yearbook and /or Website will apply.

6. By signing this document as a competitor or official partaking in a Motorsport Ireland event you are deemed by the Governing Body to have made yourself aware of the content of both this policy and the General Competition Rules relevant to you and agree to comply with same. Furthermore you are aware of the adjudication process and penalties applicable upon breaching this policy as are set out in the General Competition Rules.
